Privacy policy

In order to be able to act as an association in the interest of our members, it is necessary to file data in a structured manner or to store it electronically. All data provided by you is safe with us and will be used exclusively for internal purposes (e.g. administration of the membership directory, preparation of participant lists for events, sending of association mail such as invitations to events, general information letters, etc.) and will be passed on to third parties only for this purpose.

The following data is involved:

master data: Name, title, gender, company, availability (such as addresses, telephone numbers, e-mail addresses), membership status

Other personal data: paid membership fees, bank account details - if these are necessary for the organisation of association events.

Notes on the declaration of consent

Consent to electronic storage and processing of your data

You agree that your personal data provided by you above may be processed and used by the above-mentioned association and may be transmitted in a restricted form (name, address and, if applicable, e-mail address) to printers and shipping companies, but only

- for the purpose of supporting interested parties or members (e.g. for sending out invitations to association events, general association information, association newspapers, etc.)
- for the purpose of sending out newsletters.

You may revoke your consent at any time, free of charge and without stating reasons, by letter or e-mail with effect for the future, if necessary only with regard to one of the above mentioned purposes.

Your personal data will be stored for an unlimited period of time until you revoke your consent. In the event of a revocation, the legality of the processing carried out on the basis of the consent until revocation shall not be affected. You have the right to obtain information about the personal data stored concerning you and to restrict the processing of this data. You have the right to object to the processing, as well as a right to data transfer and a right of complaint to the competent data protection authority. We would like to point out that you have the right to have incorrect data corrected or personal data deleted if this right is not opposed by any legal obligation to retain data.

Consent to contact by e-mail

By providing us with your e-mail address, you allow us to send you information relevant to the association, such as invitations to events, general association-specific information letters, newsletters, etc. . This will help us to save time and printing costs and to use our resources even more purposefully for our association activities. You can revoke this agreement at any time in writing by letter to our association address.

Permission to take photographs and film recordings

You expressly agree that during our events (3R Days, Science & Cooking, etc.) photos and short film clips may be taken of you and that these photos and film clips may be used in digital media and print media (such as those on invitations, in newsletters, on the website, in social media, etc.) for the benefit of the above-mentioned association.
